RULES OF SCHOLARSHIP

Liaison Director: Daryl Melham

- 1 The Scholarship will be known as the Revesby Workers' Club Scholarships.
- 2 The Object of the Scholarships will be to assist Members and dependants of Members of Revesby Workers' Club to continue their education at a tertiary institution.
- 3 Eligible applicants for these scholarships will be financial members or dependants of financial members. Applicants must be under the age of twenty-one years, who are undertaking the Higher School Certificate.
- 4 Applicants: Application on the official form must be lodged with the Chief Executive Officer of the Club no later than 31 December 2015.
- 5 Awards will be determined by using the Australian Tertiary Admission Ranking. However The Scholarship Committee may exercise discretion to take other factors, including disadvantage, into account in allocating the scholarships.
- 6 The Tertiary Scholarship will be tenable at any recognised Australian University. A Tertiary Scholarship will have a tenure of a period of time as initially enrolled in as an undergraduate, and carry an allowance of \$500 per annum, payable at the commencement of Term 1, on verification of enrolment. Scholarships will be held subject to satisfactory progress as indicated by examination results. A Scholarship may be held in conjunction with any other scholarship or award with the approval of the Scholarship Committee.
- 7 Administration of these scholarships will be vested in the Scholarship Committee of Revesby Workers' Club as appointed by the Board of Directors of the said Club. Decisions of this Committee after ratification by the Board of Directors will be final. Revesby Workers' Club may, at its discretion, vary the Conditions of the award of these scholarships.
