TERMS AND CONDITIONS

Promoter

Raffle Promotion Period

The Raffle closes at 7pm AEST on Monday 15 December 2025. No entries will be accepted after this time.

Relevant States

Entry is open to residents of the following States/Territories aged 18 years or older at the commencement of the Raffle:

- New South Wales (NSW)
- Queensland (QLD)

Residents of any other State and Territory not listed above are **NOT PERMITTED** to purchase tickets in the raffle and are not eligible for any prizes.

Entry Restrictions
