

Terms and Conditions



Christmas Toy Raffle

1. The Christmas Toy Raffle is conducted at Revesby Workers' Club and will be held on Wednesday 3 and 10 December 2025.
2. Tickets are on sale from 5pm and the Raffle commences at 7pm.
3. Entry is open to all financial members and non-members of the club.
4. Participants must be 18 years and over.
5. Six (6) numbers can be purchased for every \$1.
6. Spend \$20 on raffle tickets and receive another \$20 of raffle tickets FREE.
7. Winners will be announced by public address and will have four (4) minutes to claim their prize.
8. If the prize is unclaimed following the four (4) minutes, a new winner will be drawn. This will continue until all prizes have been claimed.
9. Winner ticket must be presented at time of claim to verify win.
10. Winners must present a financial Membership Card (if applicable) and sign the prize register at time of claim.
11. Prizes include 80 toys at each raffle (various)
12. Numbers are drawn at random. Winner is able to choose any minor gift in the range.
13. Major prizes will be drawn at the end of the raffle.
14. Total value of prizes for each raffle; \$5,000.

General Terms and Conditions:

1. As with all promotions, participating members must use their own cards. Cards cannot be used by proxy.
2. Entry tickets placed into an incorrect promotional Entry Box and/or Barrel will be voided and ineligible to win.
3. No cash prizes can be awarded after 10pm.
4. Prize winners are advised that Tax implications may arise from their prize winnings and they should seek independent financial advice prior to the acceptance of the prize.
